### **Existing Pharmacy Information Flows Standard**



Defines the Information to be recorded in community pharmacies and the subset of that information to be transferred to the GP patient record for 6 use cases;

- Vaccine administration
- Emergency supply of medicine
- New medicine service
- Medication reviews (this includes the Medicine Use Review [MUR] as a contracted community pharmacy service in England, but also other types of medication review conducted by pharmacists in other settings, e.g. within care homes)
- Appliance use reviews
- Community Pharmacist Consultation Service (CPCS)

### **Objective of Enhanced Pharmacy Standard**



- Consolidation of the existing use cases into a single community pharmacy standard to reflect existing and developing service provision under the CPCF
- Consolidation of the existing standard to reflect other standard developments that have been undertaken since the publication of the pharmacy information flows standard that either relate or contribute to this work e.g., dose syntax, clinical referral standard etc.
- Review and uplift of the previous work on DMIRS and NUMSAS to reflect the Community Pharmacy Consultation Service (CPCS) launched last October (2019), incorporating both the emergency supply of medicines and minor illness consultation.
- Engagement of suppliers and users on the development of the standard to increase broader adoption across the system.
- Develop a standard with capacity to accommodate potential new services being developed or piloted under the CPCF.

### **Rationale for the Enhanced Standard**




- Enhanced standard will support emerging areas of professional activity for the pharmacy profession.
- This will ensure that new services provided by community pharmacists are visible to GP and other NHS colleagues, enhancing the standing of the pharmacy profession.
- A consolidated standard will be easier for system suppliers to implement while, at the same time providing flexibility of system design to support service functions.
- This will enable pharmacy workflow to be optimised for the benefit of both pharmacy professionals and pharmacy businesses.
- Data items align with other PRSB standard areas to ensure that, in due course, community pharmacy activity can be disseminated through NHS systems and contribute to other services.
