- 1. On 31st March 2021, PCSE started to undertake market exit and consolidation processes. Accordingly the name of their Market Entry service has changed to **Pharmacy Market Management Services (PMMS)** from 31 March 2021.
- PSCE is also seeking to drive adoption of the new portal service and looking at improving communications and the online applications process – main body corporates. As part of this they have refreshed PCSE webpages. Adding 'how to' video guides.
