Introductory briefing on the LFD service

This Community Pharmacy England Briefing provides information for pharmacy teams on the NHS Lateral Flow Device (LFD) tests supply service for patients potentially eligible for COVID-19 treatments (the LFD service).

Background

- The NHS offers COVID-19 treatment to people with COVID-19 who are at risk of becoming seriously ill.
- Prior to the introduction of this service, LFD test kits were available to order by these
 patients on GOV.UK or by calling NHS 119. These were then delivered directly to the
 patient's home.
- However, from 6th November 2023, these routes will no longer be available to eligible patients, and they will instead be able to obtain their LFD test kits from a community pharmacy.

Objective of the service

The objective of this service is to offer eligible at-risk patients access to LFD tests to enable testing at home for COVID-19, following symptoms of infection. A positive LFD test result will be used to inform a clinical assessment to determine whether the patient is suitable for and will benefit from NICE recommended COVID-19 treatments.

Brief overview

- The service officially starts on 6th November 2023; however, this is an Advanced service and pharmacy owners are free to choose if they will provide the service and when they will start providing it after the service launches.
- Pharmacy owners must have a Standard Operating Procedure (SOP) in place for this service and all pharmacy staff involved in the provision of the service must be familiar with and adhere to the SOP.





- LFD tests should be ordered through wholesalers as normal.
- The service can be provided by an appropriately trained member of the pharmacy team; however, pharmacy staff may need to refer the patient/representative to the pharmacist or pharmacy technician if they are uncertain if the patient is eligible to receive the LFD test kit.
- The service is only available for patients aged 12 years and over who are part of the potentially eligible for COVID-19 treatment cohort (as detailed in NICE guideline <u>Supporting information on risk factors for progression to severe COVID-19</u>).
- The patient's eligibility for a supply of free LFD tests needs to be confirmed before making a supply. Patients may present with a letter from the NHS which confirms their eligibility or the pharmacist or pharmacy technician may need to check, for example, by using the National Care Records Service to see if the patient has a condition which makes them eligible to receive LFD tests.
- One box of 5 LFD tests should be supplied free of charge to an eligible patient. No other pack size or quantity should be supplied.
- If there are no boxes of 5 LFD tests in stock, a member of staff should find another neighbouring pharmacy that offers the service and has stock and signpost the patient/representative to that pharmacy.
- There is no specific advice that must be provided to the patient. However, patient information does need to be obtained before a supply is made (and the patient's representative's details if they are collecting on behalf of the patient) as well as other information on the supply of the LFD tests see our data collection form for the full details which is available, along with other resources, at: <u>cpe.org.uk/lfd</u>.
