

#### Waste charges consultation

- 19. The Regulations Officer introduced the agenda paper outlining the Government consultation.
- 20. The subcommittee endorsed the following points in the agenda paper opposing the proposed charges for community pharmacy:
  - The chronic underfunding of the sector means the sector simply cannot cope with any additional costs unless this is compensated in NHS funding to the sector, agreed with the Government.





- The compliance costs are significantly less for community pharmacies because the GPhC inspects pharmacies on a regular basis, identifying and addressing issues as they arise, and the NHS also visits pharmacies and carries out other audit and compliance activities. This should mean that the Environmental Agency has less need to visit NHS pharmacies.
- There are also other waste activities carried out by community pharmacies that do not require registration; so NHS community pharmacy use of the T28 exemption could be without the required registration.

#### 21. Adding that:

- Other businesses can raise their costs to customers, but NHS pharmacies cannot charge NHS patients.
- Waste disposal is part of NHS requirements and organised activity so any related charges should be paid for by the NHS.
- Collection of medicines by community pharmacy is part of removing or reducing risks for patients, households and the public and this should not be undermined by additional charges – which could ultimately mean that pharmacies stop providing this service.
